A BILL

To direct the Secretary of Agriculture to assess the use of new technologies across reforestation activities, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Forest Technology En-
- 5 hancements for Conservation and Habitat Improvement
- 6 Act" or the "Forest TECH Improvement Act".

SEC. 2. REFORESTATION TECHNOLOGY PILOT PROGRAM.

2 (a) Establishment of Pilot Program.—Not later than 180 days after the date of the enactment of this section, the Secretary of Agriculture, in consultation 4 5 with the Secretary of the Interior, shall either establish a research, development, and testing pilot program or ex-6 7 pand an applicable existing program to— 8 assess new technologies, including un-9 manned aircraft system, geospatial, or remote sens-10 ing technologies, across all reforestation activities; 11 (2) accelerate the deployment and integration of 12 such technologies into the operations of the Secre-13 taries; and 14 (3) collaborate and cooperate with State, Trib-15 al, and private geospatial information system organi-16 zations with respect to such technologies. 17 (b) Expanding Use of Unmanned Aircraft Sys-TEMS.—Not later than 1 year after the date of enactment 18 19 of this section, the Secretaries shall enter into an agree-20 ment to develop consistent protocols and plans for the use 21 of unmanned aircraft system technologies for reforestation 22 activities. (c) Domestic Manufacture Requirement.—Any 23 24 unmanned aircraft system technology or component of unmanned aircraft system technology used under this section

shall be made and manufactured in the United States.
